Notice under Section 708A(5)(e) Corporations Act

On 17 November 2014, Optiscan Imaging Limited ("the Company") issued 1,975,000 fully paid ordinary shares upon conversion of a converting note which was issued in September 2014. The conversion price was \$0.04 per share, and the face value of the note was \$79,000.
