Optiscan Imaging Limited (ASX: OIL) (**Optiscan** or **the Company**) is pleased to advise that it has completed a partial allotment in relation to the capital raising announced to ASX on 25 September 2020. The Company has now issued 29,466,500 fully paid ordinary shares with an issue price of \$0.0825 (8.25 cents) per share. The remaining placement shares to be issued will be completed over the coming days.
